

# Request for Proposal Event Planner Consultant for Cleveland History Days

## **Purpose of Project**

In 2023, Canalway will join with local partners to host the 6<sup>th</sup> annual Cleveland History Days. Since 2018, Cleveland History Days celebrates our city's rich legacy, fueled and influenced by diverse people and immigrant groups who created a vibrant culture. In 2022, Cleveland History Days included 40 history-focused tours and programming available to the public over 10 days in June.

Canalway is a non-profit culture heritage organization that serves as a catalyst for projects and programs within the Ohio and Erie National Heritage Area in Cuyahoga County. Cleveland History Days is supported by Canalway and funded in part by the Ohio & Erie Canalway Association.

Pre-project work for Cleveland History Days will begin in January 2023 with program execution running May 1 through August 15, including event follow-up and reporting.

## Scope of Work

Canalway requests proposals from qualified professionals to act as an event planner consultant to coordinate the 2023 Cleveland History Days (CHD). We are looking for a company/person to manage the following:

- Host a planning meeting once a month with partners, February through July.
- Establish regular ongoing communication and provide meeting agendas to Canalway and all involved partners.
- In partnership with local history organizations, prepare a schedule of events focusing on history focused activities for a variety of audiences.
- Develop promotion plan for the event through a variety of marketing, communications and advertising tactics.
- Act as project manager and main point of contact between event partners and Canalway.
- Draft, manage, and finalize event project plans, timelines, deployment schedule and oversee execution of all related tasks.
- Support all events during planning and execution.
- Manage submission of all related invoices to Canalway bookkeeper to ensure payments can be made in a timely manner.
- Provide event follow-up reports.



## Scope of Services

- Open communication with existing partners to confirm participation in CHD 2023.
- Schedule monthly meeting with confirmed partners.
- Support partners in program planning and event development.
- Create a schedule of events with input from programming partners.
- Develop all printed and marketing materials from concept, through graphic design and printing.
- Monitor event budget.
- Promote the event and distribute marketing materials.
- Attend Cleveland History Days events as needed and provide partners with support on their event day.
- Gather metrics during the event such as attendance.

### **Personnel Experience**

Event consultant should demonstrate 2+ years of professional experience planning and executing successful live events, including securing and stewarding partnerships. Non-profit event experience preferred. Strong computer skills, including some graphic design experience preferred. Understanding of on-line event platforms for posting and promotion of event. Strong interpersonal and communications skills, including the ability to partner collaboratively with other organizations. Ability to work in a professional and positive manner with high attention to detail in a variety of situations.

### **Submission Requirements**

The proposal should demonstrate the capability of the firm / consultant to perform the above stated services. Please include:

- Professional qualifications which may include resume, biography, or on-line portfolio
- Minimum of two references from clients
- Executive summary featuring background and past experiences similar to the services expected for Cleveland History Days.
- Outline of fee structure
- Any additional information the Event planner believes relevant to the RFP.
